

Ball Aerospace Moves NPP Satellite to Thermal Vacuum Chamber for Final Testing

BOULDER, Colo., April 14, 2011 /PRNewswire/ -- Ball Aerospace & Technologies Corp. has moved the NPOESS Preparatory Satellite (NPP) to the thermal vacuum chamber for final testing. NPP was lowered into Ball's chamber on March 2, 2011, to simulate the harsh rigors of space the satellite will encounter when it is launched in October 2011. Thermal vacuum testing is a major milestone for the NPP satellite with completion anticipated by May 1, 2011.

The NPP mission will continue critical weather and climate measurements by flying a suite of advanced-technology remote sensing instruments.
